Dear Brothers and Sisters in Christ,

As I write this month's newsletter article, it is just a few days before we turn the calendars and close out 2021 while at the same time welcoming the New Year and celebrating the arrival of 2022! The start of every New Year gives us the opportunity to reflect upon the past year and discover once again God's faithfulness in Christ. Intentional Interim Minister

Following the special voters meeting sessions November 13th and 14th, and the voters approval for Trinity to proceed with calling an Intentional Interim Minister (IIM) as we continue going thru the transition to call a full time Sr. Pastor, we informed the District Office of our congregational vote and was advised to provide a letter making an official request for the IIM. That letter was provided to District on December 10, 2021 and we are awaiting names of prospective IIM's, with their background information, to interview and make a recommendation to the congregation of our choice. The process has been slowed somewhat as both President Walton and his wife tested positive for COVID around the Thanksgiving time and he was not in the office until mid December. When we receive the list on prospective IIM candidates, we will share those names with the congregation.

Music Director

The music committee is continuing their search for the music director here at Trinity. As of mid-December they had received 5 resumes and conducted 4 telephone interviews. The 5th individual was deemed not qualified, therefore, was eliminated. The cutoff date for candidates to submit their resumes was December 20th. Three candidates will be selected for in person interviews and auditions to be conducted in early January 2022. Two of those three will be ask to return to demonstrate their ability to lead and conduct the choir. Our actual choir will be brought in for that activity.

We continue to thank those individuals who are providing the music support for all our church services during this time of the music committee working through our search for our new music director.

Annual Voters Meeting

The annual December voters meeting, with the primary purpose of electing officers and board members, was held on December 12. 2021. Minutes of previous voters meetings from August 29, 2021 and the special voters meeting sessions of November 13 and 14, 2021 were approved as written.

The election of officers and board members were conducted with Paul Stieber being nominated from the floor to run in addition to Carolyn Fortin for Vice-President and Dave MacTrinder added to the board of Trustees.

The results of the vote for Vice-President was Carolyn Fortin receiving 73 votes and Paul Stieber receiving 23 votes therefore Carolyn Fortin is the Vice-President elected for the 2022-2023 calendar years. Joan Egeland was elected as Church Secretary and all board members were elected as presented.

Treasurer Gary Eckoff presented the 2022 proposed budget. After discussion on several items, the budget was approved for the 2022 calendar year. This is the first time in several years a balanced budget was presented to the voters assembly.

Gary then presented information that Trinity Lutheran Church is the beneficiary from a past member's estate and the Administrator has sent a preliminary report of the estates distribution and Trinity could potentially receive approximately \$470.000. The final dollar amount and distribution from the estate should take place during 2022.

The Finance Committee and Church Council previously discussed at length how we should distribute these funds. The recommendation from Church Council to the voter assembly is that Trinity do a 10%, 10%, 80% distribution with 10% being designated for Missions, 10% being retained by Trinity to be used by and for Trinity at the Church Council discretion and 80% be paid to Thrivent to be applied against the principle of our loan on our Sanctuary. Gary made three different motions for the 10% to mission, 10% to be retained by Trinity and 80% applied against the principle of our Sanctuary loan. After discussion on each motion, all three motions were approved by the voters.

Transition Team

We have 11 volunteers to be on the Transition Team: Carolyn Fortin (Chair), Pam Bixler, Roy Egeland. Bill Schwieger, Al Etzler, Jane Wood, Carol Keenan, Joan Egeland, Paul Stieber, Marilyn DeTizio, Joyce Mussey. Gil Dahnke and Jill Esposito both will be Ex-Officio members.

We plan to have a team meeting in early January to begin gathering information and data for our transitional documents which will aid the call team later.




THANK YOU-

PLANE CRASH SURVIVOR TO APPEAR IN CONCERT

Sunday, January 16 5:00 PM Reception 6:00 PM Concert

On Sunday, January 16 at 6:00 pm plane crash survivor, Dave Anderson, joined by his colleague Roger Walck, will appear in concert at Trinity Lutheran with a Reception at 5:00 p.m.

In August, 1993, Dave Anderson, his wife Barbara, and five others were returning from a mission in the Russian Far East when their chartered twin-engine plane crashed into the Bering Sea, 144 miles south of the Arctic Circle and 22 1/2 miles west of Nome, Alaska.

This group of missionaries spent nearly an hour in 36-degree water without life jackets or rafts. Life -expectancy in 36-degree water is between five and thirteen minutes. They were spotted after they had been in the water for twenty minutes and twenty minutes after that, two commercial helicopters came to carry out what has been described as one of the most dramatic air/sea rescues in history...anywhere in the world.


As part of the evening concert at Trinity Lutheran Church, Dave will retell parts of The Rescue Story which has been seen and heard by millions of people around the world in person, on TV and radio and in many languages. The Rescue Story book and DVD will be available at the concert.

The Global Missions committee appreciates your help in spreading the Gospel around the world, especially to hard to reach areas where children may learn of Jesus Christ for the first time. How exciting that will be for them.

On November 19th, we delivered Trinity's boxes to First Baptist Church of Belleview. This began the first leg of their long journey. Then they went to Atlanta for processing and are now on their way. We hope you will continue to pray for this rewarding ministry and the many lives touched with Christ's love and hope.

More about Angola from Samaritan's Purse

Located on the western coast of Africa, Angola is known for its natural resource of oil as well as its recent recovery from decades of civil war. Operation Christmas Child began delivering gift-filled shoeboxes to children in this nation in 1997 and many have participated in our follow-up discipleship program, The Greatest Journey, since we launched it here in 2010.

With congregational financial matched gifts, over \$500,000 was raised to pay off our fellowship hall loan, and again at the end of the year an estate gift of almost the same amount to be used at Trinity for additional loan repayment and support numerous missions. Instead of leaving estate gifts to family only to be discovered when the will is read someday, gather your family together and openly share with them the blessings you hope these future gifts will bring.

Also, think now of the gifts you plan to give to ministry. Set up a meeting to discuss your gift with the pastor or stewardship board chair and talk about what you hope the gift will accomplish in ministry. They can offer considerations that are not normally applied via trusts or wills that can prove beneficial to one's planning.

With some work and careful planning and communication, you can bring the joy of giving into your life as you disperse God's gifts to the family you love and to the ministries you care about the most.

THE SEWING ANGELS (AKA Scrappy Quilters)

Big News in the New Year! We have decided to rename our group! Years ago our founding sisters were busily working on their quilting projects. Pastor Abrams was passing by and jokingly said they were just a bunch of Scrappy Quilters! That is how we got our name. As years have gone by the mission of the Scrappy Quilters has grown beyond just quilts, to sew many things which bring joy and comfort to many. My sisters kept calling me their sewing angel and I thought that is exactly what the Scrappy Quilters are - a beautiful group of sewing angels. I brought the name change idea to the group and it was voted unanimously to be called The Sewing Angels of Trinity Lutheran Church.

Since I last wrote on November 15th my sewing angels have delivered to GG's house 8 floor pillows, 281 drawstring Santa bags, 31 soapy washcloths, 2 pillowcases, 8 ponchos, 100 crocheted Christmas Bell Ornaments and 37 crocheted Christmas card ornaments crafted by Debbie Zwolak. Our contact at Dollar Tree came through with a huge box full of toys to help fill the Santa bags. Julia Mack campaigned in her Del Webb community for help with donations to help fill 24 bags with hygiene items for the teenagers. Enough cash was donated to purchase toiletry items and washcloths. Extra bars of soap and the washcloths will be used to make more soapy washcloths.

Our main focus now is sewing blankets. We are using excess fleece fabrics from the poncho project and quilted fabric that was donated. We are pairing fleece or quilted fabrics with a coordinating fabric we have on our shelves, sewing them together and then tying the layers as we do the quilts. No batting is used in this project. We have about 20 in progress at this time. Distribution of the blankets will begin in January.

At our last meeting in 2021 on December 17th we set time aside to just relax, visit and enjoy some refreshments. We picked items from our shelves to contribute to a project one of my neighbors is heading up to bless Senior citizens in nursing homes in Leesburg who are lonely on Christmas.

I hope everyone had a blessed Christmas. Thank you for your support of our sewing ministry. Together we can make a difference! The first meeting of The Sewing Angels in 2022 is January 7th. As always we meet from noon till 3 in meeting room 1. Please keep our ministry in your prayers and prayerfully consider joining us! Best wishes for a Happy, Healthy New Year.

"Will a mere mortal rob God? Yet you rob me. "But you ask, 'How are we robbing you?' "In tithes and offerings. You are under a curse—your whole nation—because you are robbing me. Bring the whole tithe into the storehouse, that there may be food in my house. Test me in this," says the LORD Almighty, "and see if I will not throw open the floodgates of heaven and pour out so much blessing that there will not be room enough to store it. (Malachi 3:8-10)

It's time to say good-by to 2021 and hello to 2022. Will someone please tell me where the year went? Anyway, as one of my favorite songs states, it is time to "turn the page." It is time to move on to new adventures and look forward with anticipation of what a new year will bring, and to also discover what the year has in store for Trinity.

Before I move on, I would like to reflect on the congregational meeting in December. I was told by several people that they were amazed at how much interaction there was by the congregation. Since this was my first December annual meeting at Trinity, I have nothing to compare it to. But it seemed to go remarkably smooth compared to other congregational meetings I have been a part of.

I was encouraged by the fact that there was more conversation about the financial state of Trinity than any other issue presented. And rightly so. It has been my experience that the financial health of a congregation speaks volumes about its overall health. Especially its spiritual health.

No, the people leaving the church were those who were disinterested in the inner workings of Trinity. And I get it. Sometimes church meetings are so Booooooring (like a Dean Smith four corner offense). They should be bottled and sold as a cure for insomnia. But still, each and every voice should be heard. And yes, it is important that you vote.

I spoke with a couple of people as they walked out to get in their car to leave and reminded them that their voice was important. I was shocked at their response. Which was, it the same old, same old, same old. No matter what good suggestions are brought out, they are voted down, and the leaders just get their way. So. they said, "why should I stay? I'm headed out to breakfast." The sad part about the statement is that it contains a whole lot of truth. After they left, I went into the meeting with a new prospective. To judge for myself if what they said was true. I came to the conclusion that for the most part, they were correct. For the first part of the meeting the material presented was pretty mundane and not thought provoking. Passing minutes of past meetings doesn't do much for the stirring of one blood and emotions. Likewise, the nomination of new committee members does not do much for arousing heated debate.

However, when it comes time to talk about money, that has the capability of awaking the almost asleep to being wide awake. Why do we worry so much about dollars and cents? Does not God own the cattle on a thousand hills, and could he not sell a couple and send the funds to Trinity? That is exactly what we found has happened. Some one has left us quite a sizeable bequest in their will. Now comes the important part. How are we going to spend it? Once that was settled and the funds designated and spent, we could move on. Yes, I know that that was one of the last items on the agenda.

No Easy Answers: Part 13

The biggest and most time-consuming item was the "Budget." but what is a "budget?" A budget is an estimation of revenue and expenses over a specified future period of time, and is usually compiled and re-evaluated on a periodic basis. Budgets can be made for a person, a group of people, a business, a government, or just about anything else that makes and spends money.

To manage your monthly expenses, prepare for life's unpredictable events, and be able to afford big-ticket items without going into debt, budgeting is important. Keeping track of how much you earn and spend doesn't have to be drudgery, doesn't require you to be good at math, and doesn't mean you can't buy the things you want. It just means that you'll know where your money goes, and you'll have greater control over your finances.

Now that there is an operational definition for what a budget is, let's move on. First of all, I do not like the term "budget" for a church. To me it indicated that we do not have any ministry or any plans for the ministry. But of course, we do. I prefer the term "Ministry Plan." It implies that we have ministries, and we have plans for those ministries. There is an old saying in the non-profit world. It goes, "donors give to programs and not to budgets." If it is true, that may explain why Trinity's finances are eighty-five thousand in the red for 2021 (that is as of this writing and what was presented to the congregation). It would be even more in the red if you took away the PPP funds we received in 2020.

Whether you give to a budget or a ministry plan, or even if you do not give at all, and yes, it is about the tithe, or some may say giving of offerings to God our Father. First of all, we who call ourselves Christians, follow a Jewish Messiah. Jesus was never a Christian. He is, was and always will be Jewish. Christianity could be and in some places is considered a sub-set of Judaism. If that be the case, we are to follow the laws and precepts that God handed down to the Jewish people. If that is true, then we are still commanded to follow God's teachings when it comes to giving. Just in case you are not familiar with them let me fill you in.

If you read the books of Leviticus, Numbers and Deuteronomy, or go the Bibleqateway.com and search for tithe, you will find that for the Jew there were three offerings they were to bring. The first was a tithe every year for the maintenance of the temple. The second tithe, due each year, was to support the temple feasts and festivals. The third tithe was due every third year and went to the benevolence fund to support the widows and orphans and sojourners in the land. If you broke it down and wanted to pay it each year that would mean your tithe to the church should be twenty-three and one-third percent. A whole lot more then we are asked to contribute today.

The scriptures tell us to bring all the tithes into the storehouse so that the floodgates of heaven will be opened and blessings from God our Father will be so many that we will not have room to receive them. If you do not want to give to a "Budget" try giving to our "mission" which "is to share the good news of Jesus the Christ by serving the spiritual, social, family and personal needs of the community." What do you say? Do you want to give it a try and see what happens? I think we should.

Trinity Lutheran Church Voters Assembly Minutes December 12, 2021

Council President Gil Dahnke called the meeting to order at 9:15 AM. Pastor Blair opened the meeting with prayer. There were 113

voting members present.

The minutes of the Voters Meeting of August 29, 2021 were presented. There being no changes, Col. Carlan moved: <u>MOTION</u>: *The minutes of the Voters Meeting of August 29, 2021 shall all be accepted as presented.* Motion was seconded and carried. The minutes of the three sessions of the November 13 & 14, 2021 Special Voters Meeting were presented. There being no changes, Jan Garner moved: <u>MOTION</u>: *The minutes of the three sessions of the November 13 & 14, 2021 Special Voters Meeting shall all be accepted as presented.* Motion was seconded and carried.

ELECTION OF OFFICERS AND BOARD MEMBERS: Jane Wood nominated Paul Stieber for the office of Vice President. Nominations were closed for Vice President. By a show of hands, the current Vice President Carolyn Fortin, received 73 votes; Paul Stieber received 23 votes. Carolyn Fortin was elected Vice President for her first full term January 1, 2022-December 31, 2023. President Dahnke appointed Gary Eckoff as Treasurer for his third term from January 1, 2022-December 31, 2023. Joan Egeland accepted the nomination as Recording Secretary for her first half term January 1, 2022-December 31, 2022. There being no objections, Joan Egeland was elected as the Recording Secretary. Board members up for re-election for a two year term to end December 31, 2023 (copy attached) were presented. Col. Carlan moved: MOTION: The Board Members shall be accepted with Dave MacTrinder being added to the Board of Trustees and Hugh and Lou O'Brien being removed from the Board of Human Care. Motion was seconded and carried.

2022 BUDGET: Gary Eckoff presented the Treasurer's report (copy available from the office) for the first 10 months of 2021. Gary then reviewed the Proposed 2022 General Fund Budget (copy attached). Patti Paxton moved: **MOTION:** The General Fund Budget for the 2022 be accepted as presented. The motion was seconded by Col. Carlan. Bob Behrends moved that the motion on the floor be amended to take the Bushnell mortgage out of the Missions line of the Operating Expenses, and put it back into the General Budget. Jan Garner seconded. Votes FOR the Amendment 29; Votes AGAINST the Amendment 64. The amendment did not pass, and the original budget motion was voted on and carried. The 2022 General Fund Budget was approved as presented.

Gary reported that Trinity Lutheran Church is the beneficiary of a past member's estate. The administrator has sent TLC a preliminary report reviewing the estate's distribution to each beneficiary. TLC's share is 25%, which means we could potentially receive approximately \$470,000. Final distribution should take place in the next 6-10 months. The Church Council discussed, at length, how these funds are to be distributed/spent in 2022 and beyond. It was resolved that TLC do a 10%-10%-80% split as follows: 10% given for God's Mission work; 10% to TLC; 80% principal payment to Thrivent on the Sanctuary loan. Gary Eckoff moved:

MOTION #1: Voters shall accept the following designation of 10% of the total amount received from the member's estate for MISSIONS, as recommended by the Finance Committee. Of these funds, (a) 10% to Florida-Georgia District; (b) 10% to Trinity Missions as directed by the Pastor, and (c) 80% to be distributed to National/International Missions per the Evangelism Board, with the Pastor's input. Patti Paxton seconded. Motion carried.

MOTION #2: Voters shall accept the designation of 10% of the total amount received from the member's estate, as recommended by the Finance Committee, to be used by and for Trinity Lutheran Church. These funds will be distributed at the Council's discretion. Mike David seconded. Motion carried.

MOTION #3: Voters shall accept the designation of 80% of the total amount received from the member's estate, as recommended by the Finance Committee, to be used to pay down the principal on our Sanctuary loan with Thrivent. Patti Paxton seconded. Motion carried.

OLD BUSINESS:

<u>Music Director Update</u>: Music ministry has received five candidates. The next meeting will be December 13, 2021 with in-person interviews with 4 of them. Interviews will continue.

<u>Intentional Interim Minister Update</u>: President Walton asked for an official letter from TLC requesting the IIM and it has been sent.

<u>Transition Team Update:</u> Eleven people volunteered to be on the Transition Team: Carolyn Fortin, Chair, Pam Bixler, Marilyn DeTizio, Joan Egeland, Roy Egeland, Al Etzler, Carol Keenan, Joyce Mussey, Bill Schwieger, Paul Stieber, Jane Wood, Gil Dahnke, ex-officio, and Jill Esposito, ex-officio.

There was no new business to come before the meeting.

The next Voters Meeting will be June 26, 2022. There being no further business, **Jeff Bixler moved to adjourn**. Motion was seconded and approved. President Dahnke adjourned the meeting at 10:10 AM.
